Each and every artist is expected to donate his or her time to meet the organizational time-line for the tour. Please see Section 3 of the Visions Art Tour Society Policy and Procedure Manual for a description of the many tasks that require member participation to ensure the success of the Visions Art Tour Society.

With membership, Visions offers their members:

- Listing on the Visions website
- Public exposure in pre-tour shows, news releases
- A quantity of brochures for distribution
- Support of fellow artists

As a tour participant, the venue host is also provided with:

- Loaned direction road signage during the tour (\$10 deposit, refunded with return of signs)
- Liability insurance during Visions Art Tour Society events
- Feature space in the tour brochures.

Member obligations:

- - Meet all deadlines. Critical dates will be listed on the Visions website at www.visionsarttour.ca.
- - Participate on one of the committees.
- - Attend general meetings and your committee meetings to keep informed of Visions' activities.
- - Do your share to advertise the tour to your friends, family and general public.

Venue (tour participant) obligations:
